Welcome: The meeting was called to order at 7pm.

Clinical Issues:

- CBD Update: the DEA has cracked down on WI pharmacies prescribing high-THC content CBD oil. It no longer seems widespread to be able to purchase higher THC oils. However, there is a ballot initiative on 'medical marijuana' for the November election that polling suggests has widespread support and is likely to pass.
- Medication First Program. Dr Olson brought up his interest in collaborating on the idea of ED physicians providing a small supply of buprenorphine to patients coming into EDs in need of treatment for Opioid Use Disorder, ideally as a bridge for them to access treatment services. There was a discussion on the pros and cons of such a program. Dr Olson provided a [link to an article](#) on Mass General's Medication First program. If others are interested in learning more or collaborating, this could be discussed at a future teleconference.
